Payment in advance by e-Transfer

Please do **not** send an e-transfer until you have received your acceptance letter. Once you have received your acceptance letter, you will then be required to submit an e-Transfer of the required \$500 deposit to hold your seat in the training. The remaining balance **must be paid in full 14 days before the training begins**. If the balance is not paid in full 14 days before the training begins, you will be charged the standard registration fee.

Payment by Credit Card

The EMDR Center of Canada Inc. offers an installment plan by credit card only. Only Visa and Mastercard are accepted for the payment plan. Those who prefer may complete an installment contract authorizing payments by credit card with your application for registration.

For **Early Registration**, licensed or registered clinicians will pay 3 installments of \$766 + GST for a total of \$2,412.90; discounted early registration will pay 3 installments of \$714 + GST for a total of \$2,249.10.

For **Standard Registration**, licensed or registered clinicians will pay 3 installments of \$804 + GST for a total of \$2,532.60; discounted standard registration will pay 3 installments of \$752 + GST for a total of \$2,368.80. All prices are in Canadian (CDN) funds.

Three installments will be charged as follows:

- 1) On acceptance of your application
- 2) the 1st training weekend
- 3) the 3rd training weekend

Note: If you request a single credit card charge, the total will be the same as for the three applicable installments listed above.
